We provide a special scholarship for individuals in Thailand to aid them in developing skills and a network to help with COVID-19 recovery and building a brighter tomorrow.

# **Scholarship Outline**

## Criteria for Eligibility

#### Applicants need to fulfill the following requirements:

- Residing in Thailand at the time of application
- Applying as an individual to a Pre-MBA course offered by GLOBIS Thailand
- Has not previously taken GLOBIS courses before and is currently not enrolled in any other GLOBIS courses
- Has a strong will to contribute to Thailand and its business environment

**Note:** This scholarship is only applicable to Pre-MA courses offered by GLOBIS Thailand and will therefore not be applied to Pre-MBA courses taken at other hubs or offered by GLOBIS University in Japan.

# Scholarship Amount

Covers 30% of the Pre-MBA course fees at GLOBIS Thailand

## How to Apply

Application is done via the Pre-MBA application page on the official website of GLOBIS Thailand. Applicants meeting the above criteria will be automatically considered for the scholarship during the Pre-MBA application process.

### **Results Notification**

Applicants will receive a notification after registering for their course together with the invoice for the Pre-MBA course fee.

## Scholarship Period

This scholarship has been created due to the extraordinary circumstances caused by COVID-19 and is therefore subject to change in the future. Updates on scholarship availability will be shared via our website when necessary.

## Loss of eligibility, leave of absence, withdrawal, expulsion

- Withdrawal from the Pre-MBA or expulsion results in loss of eligibility to further receive the scholarship.
- Should GLOBIS Thailand deem the recipient to act inappropriately, it will terminate the scholarship.

To support business professionals who aspire for higher education and professional growth, we have initiated an Enrollment Fee Exemption which exempts applicants from paying the Pre-MBA enrollment fee until enrolling in the MBA program.

# **Scholarship Outline**

## Criteria for Eligibility

### Applicants need to fulfill the following three criteria to be eligible:

- 1. Clear desire to enter GLOBIS University's MBA programs (through a separate admission process) in the future, starting with Pre-MBA courses at GLOBIS Thailand.
- 2. Initial Pre-MBA course(s) is/are registered and paid by the individual (not corporate-sponsored)

**Note:** Those who are sent to study by their company, or those who expense their course fees partially or fully with the aid of their company will not be eligible for this scholarship.

3. 30 years old or above during the time of application (including applicants who will turn 30 by December 31, 2020)

**Note:** This scholarship is inapplicable to those who are under 30 and eligible for the *Young Leaders Scholarship*.


## Scholarship Amount

The Pre-MBA enrollment fee of 6,800 THB (Excl. VAT) is waived up until MBA enrollment.

**Note:** Should a recipient enter one of our MBA programs, the enrollment fee for the MBA program will need to be paid in full (80,000 JPY for our Part-time & Online MBA, 225,000 JPY for the Full-time MBA).

**Note:** GLOBIS University MBA entrants who do not receive a waiver and have paid the Pre-MBA enrollment fee will have that fee deducted from their MBA enrollment fee (57,000 JPY remains for the Part-time & Online MBA, 202,000 JPY remains for the Full-time MBA).
